

## **Privacy Policy**

This policy sets out how we process any personal data we collect from you or that you provide to us through our website. ### Types of information we may collect from you

We may collect, store and use the following kinds of personal information about individuals who visit and use our website:

Information our website automatically collects about you. With regard to each of your visits to our website we may automatically collect information including the following:

technical information, including a truncated and anonymised version of your Internet protocol (IP) address, browser type and version, operating system and platform;  
information about your visit, including what pages you visit, how long you are on the site, how you got to the site (including date and time); page response times, length of visit, what you click on, documents downloaded and download errors.

### Cookies

Our website uses cookies to distinguish you from other users of our website. This helps us to provide you with a good experience when you browse our website and also allows us to improve our site.

### How we may use the information we collect

We use the information in the following ways:

Information you supply to us. We will use this information:

to provide you with information and/or services that you request from us as well as to provide registered counterparties to the extent required for the purpose of rendering services through the OMHub website.

Information we automatically collect about you. We will use this information:

to administer our site including troubleshooting and statistical purposes;  
to improve our site to ensure that content is presented in the most effective manner for you and for your user experience;  
security and debugging as part of our efforts to keep our site safe and secure.  
This information is collected anonymously and is not linked to information that identifies you as an individual. We use Google Analytics to track this information.

#### Disclosure of your information

Any information you provide to us will be stored on a secure server. We use a trusted third party website and hosting provider to facilitate the running and management of this website. Such provider meets applicable data protection and security standards and is bound by contract to keep any information they process on our behalf confidential. Any data that may be collected through this website for data processing, is kept secure and only processed in the manner specifically instructed. The hosting provider cannot access, provide, rectify or delete any data that they store on our behalf without permission.

We do not rent, sell or share personal information about you with other people or non-affiliated companies.

We will use all reasonable efforts to ensure that your personal data is not disclosed to regional/national institutions and authorities, unless required by law or other regulations.
